Below, we have outlined some of the particular BAAS initiatives this year we would like to draw your attention to.

Targeted Research Panels (TRP Lead Riziki Millanzi)

We are delighted to have been able to continue funding Targeted Research Panels. These aim to support, promote, and feature the production of research by people of colour, LGBTQ+

communities and disability communities. This year we have four total panels, with two returning for their second presentations and two new panels:

- Magazine Margins: Advertising in magazines for lesbian sex-radicals, Black Americans, and interracial families in the late-twentieth century (2026–2028)

Green BAAS (Green BAAS Lead Elsa Devienne)

Green BAAS remains committed to its three goals of Greening American Studies Teaching, Greening American Studies Research and Greening BAAS as an organisation. Green BAAS will also be supporting the panel "Big Plans and Limited Resources: Water and fossil fuels, 1890-1990" (submitted by Julia Guarneri).
